From January 2021-April 2022, Washington State Essentials for Childhood (EFC) and Bezos Family Foundation funded the activation of Vroom™ through 9 community-based partnerships.

Since the activation of Vroom™ more than 26,7000 families have been reached, and 905 community partners trained as a statewide effort to share Vroom with families through various community outreach efforts.

Universal Developmental Screening (UDS)

WCAAP continues to move forward with their UDS Learning Collaborative. Pediatric providers from SeaMar clinics in Whatcom and King counties are participating in a 6-9-month collaborative focused on developmental screening, connection to resources, and implementation of the [Strong Start](#) data system.

Skagit Public Health Department is participating in a soft launch of the Strong Start system, working with their local partners, and will provide input to DOH on the user experience. Other interested soft-launch partners include Chelan-Douglas Health District, Lincoln County Health Department, and Tacoma-Pierce County Health Department.

We are currently identifying one or two clinic partners to begin exchanging data with the Strong Start system via One Health Port (OHP). Interoperability with electronic health records is a priority ahead of the planned statewide system rollout in 2023.

Mental Health Assessment for Young Children

Christine Cole & Kiki Fabian, Health Care Authority

Updates: HCA would like to take this time to share updates on the implementation of Second Substitute House Bill 1325 Sec (2)(11) as well as what we have heard from providers and partners throughout the process. As we have implemented this policy, we have transitioned to referencing this work as Mental Health Assessment for Young Children or MHAYC. The following will include HCA's implementation steps as well as input and feedback from the field more broadly. It is worth noting that what we share in terms of feedback was not exclusive to HCA specific next steps but reflects opportunities for the Infant-Early Childhood Mental Health field broadly.

Diagnostic Classification of Mental Health and Developmental Disorders of Infancy and Early Childhood (DC: 0-5)

DC:0–5 provides a common language that allows individuals across disciplines—mental health clinicians, counselors, physicians, nurses, early interventionists, social workers, and researchers—to communicate accurately and efficiently with each other and to link to knowledge about early childhood disorders. It is an important tool for clinicians, researchers, faculty, and policymakers.

First, understand multiple aspects of a child's life *from the family's perspective* BEFORE diagnosing – culture & community, family relationships, life circumstances, motor, cognitive, & communication development, and medical conditions

Requires multiple visits/sessions to gather all the information

Should be done in home or community settings where the child and family are comfortable

Then, look at emotional/behavioral symptoms, with a developmental lens:

Developmentally specific diagnostic criteria for mental health disorders (i.e. depression for a 3-year-old looks different than a 30-year-old)

Additional mental health disorders that are developmentally specific for in infancy and early childhood (e.g. Overactivity Disorder of Toddlerhood, Excessive Crying)

Who do these policies apply to?

- Independently licensed mental health providers
- Mental health providers working for a licenses Behavioral Health Agency

Provider Travel Reimbursement: Effective January 1, 2022, mental Health providers can submit A19 invoices for mileage reimbursement for intake assessment sessions.

When are Apple Health Mental Health professionals required to use the DC: 0-5?

The law as passed **does not have an explicit implementation date** for use of the DC:0-5™. HCA interprets the intent of this legislation to support the field in moving to the standard and expected use of the DC: 0-5™ for children birth through age 5. Current efforts are focused on building workforce capacity to support this new legislation through free

DC:0-5™ trainings for Apple Health providers and the publication of the Apple Health DC:0-5™ crosswalk. HCA has also updated mental health billing guidance to reflect the use of the DC:0-5™ as the developmentally appropriate diagnostic classification tool and is hosting monthly Office Hours to support providers and agencies in their implementation of the updated guidance.

Fostering Well-Being (FWB)

Jesenia Stark, Washington State Department of Social and Health Services

Regional Medical Consultant's (RMC): RMC's are part of the FWB team as part time pediatricians located through the state covering all regions

What FWB does:

- Review every Child Health and Education Tracking Screening (CHET) Report and Expedited Referrals
- Provide Medically Fragile Group Home (MFGH) Consultants and recommendations
- Participate in Health Care Authority Clinical Utilization Review
- Review and Resolve Health Care Authority service/durable, nondurable pending denials
- Create Comprehensive Health Overviews for infants, children and youth
- Health Education Materials
- Review HCA's report

- Attend various local and statewide meetings, Tribal meetings and trainings, along with being committee members

Who qualifies for FWB Care Coordination?

FWB is available for care coordination for Apple Health (fee-for-service Medicaid) population.

The children and youth include the following populations:

- Tribal-affiliated or in tribal custody and have not opted to enroll in managed care organization (MCO) due to being American Indian/Alaska Native, or
- Non-Citizen status, or
- Existing enrolled clients (prior to April 1, 2016) in the Health Care Authority (HCA), Medically Intensive Children's Program (MICP)

A: Yes

PAL Program & MH Referral Line

What is "PAL"?

- State sponsored program
- All primary care providers can access child psychiatrists for a phone consult on any child
- In operation since 2008
- 866-599-7257

Unique Aspects of PAL

- Pal hosts free psychiatric care education conferences
- Free, expert reviewed care guide for providers at seattlechildrens.org/pal
- Social worker can inform primary care practices about local mental health care resources
- PAL also operates WA Mental Health Referral Service for parents to call themselves to request referral help at 833-303-5437

Mental Health referral service for Washington's Children and Teens

- Added over 2,000 child mental and behavioral health care providers
- Referral Line is for any parent to request resources

What A Common Voice Do:

Support in Accessing & Navigating the WA Behavioral Health System

- 1;1 Virtual and Phone Support
- Meeting Support (DDA, WISe, CLIP, IEP, etc.)
- Support Groups & Trainings

Lead Parent Support Specialists

- Highly trained parent leaders who have extensive experience in navigating the WA Behavioral Health System
- Consultants and trainers representing parent voice for various state initiatives
- Certified Parent Advocates with lived experience

Direct Parent Support

- No cost to parents/ caregivers regardless of insurance
- Youth do not have to be enrolled in Mental Health Services
- Connect families to relevant resources, supports, services

- Support during transitions/ graduation out of WISE, CLIP, Residential Schooling, etc.

What A Common Voice does not do:

- Not a crisis-line! ALL LPSSs will refer all crises to mental health providers, WISE teams, and / or 911
- Regardless of expertise, experience, or credentials of the support team it is not designed or intended to replace the need or services of mental health providers
- LPSS support differs from WISE, or CLIP parent partner roles and it's not intended for long-term 1:1 support
- A Common Voice | COPE Project does not follow a "do-for" model, but rather a "do-with" model. LPSS support is always meant to empower parents / caregivers; to advocate WITH rather than advocate

Community- Based Services

- There are hundreds of IBH visits through SCCN each month.

Outpatient Services

- Increased referral for outpatient care in 2021 and 2022
- In the past 12-18 months, Seattle Children average about 200 referrals to Outpatient Psych services each week & about 100 referrals to the Autism Center each week

Inpatient and Embedded Services

- PBMU beds are almost always full- either to 41 or to what we can staff safely given patient acuity
 - Length of stay increased from approx. 7 days in FY18 to 13 days in FY22- a 6-day increase
- Psych Consult and Liaison has seen increased numbers of patients presenting with eating disorders
- Seasonality to EDMU census (peaks in Spring and Fall) but increasing year over year
- The ED Mental Health (EDMH) team has seen increased need and worsening access to care in the community.
 - March 2022- highest EDMH census on record (411 patients in one month).

Current issues/ Trends

- Limited community resources contributing to longer lengths of stay on the PBMU and in the ED

- Extremely limited community supports for youth with ASD/IDD
- Increasing concerns about frequency of patients abandoned and stuck in the hospital setting
- Workforce challenges across the continuum of care
