In accordance with WAC 246-310-080, Pacific Cataract and Laser Institute, Inc., P.C. ("Pacific Cataract and Laser Institute") hereby submits this Letter of Intent proposing to operate a three-operating room certificate of need approved ambulatory surgery center ("ASC") in the Clark County secondary health services planning area. Pacific Cataract and Laser Institute has historically operated the ASC as a one-operating room certificate of need exempt ASC. Pacific Cataract and Laser Institute seeks to relocate and expand that ASC.

Pursuant to WAC 246-310-080, Pacific Cataract and Laser Institute submits the following information:

2. *Estimated cost of proposed project:* The estimated capital expenditure for the project is \$5,994,233.25.
3. *Identification of service area:* The service area is the Clark County secondary health services planning area.
